Volunteer Release of Liability & Assumption of Risk Agreement

Community Clean-Up Day

By signing this agreement, I acknowledge and agree to the following:

1. Voluntary Participation

I understand that my participation in the Palo Del Amo Woods Community Clean-Up Day (“Event”) is completely voluntary.

2. Assumption of Risk

I understand that participation in the Event may involve certain risks, including but not limited to slips, falls, cuts, insect bites, exposure to weather conditions, lifting-related injuries, contact with debris or hazardous materials, and other unforeseen risks associated with outdoor community clean-up activities. I voluntarily assume all risks associated with participating in the Event.

3. Release of Liability

In consideration of being permitted to participate in the Event, I hereby release, waive, discharge, and hold harmless the Palo Del Amo Woods Homeowners Association, its board members, officers, committee members, volunteers, agents, representatives, and affiliates from any and all claims, liabilities, damages, injuries, losses, costs, or expenses, including attorney’s fees, arising out of or related to my participation in the Event, including claims caused by negligence to the fullest extent permitted by law.

4. Medical Responsibility

I certify that I am physically able to participate in the Event and understand that the Association will not provide medical or health insurance coverage for participants. I understand that I am solely responsible for any medical expenses incurred as a result of participation.

5. Minimum Age Requirement

I acknowledge that participants must be at least eighteen (18) years of age to participate independently. Any minor participating must be accompanied and supervised by a parent or legal guardian who must also sign this agreement on the minor’s behalf.

6. Compliance with Safety Instructions

I agree to follow all safety instructions, rules, and directions provided by Event organizers and to use reasonable care while participating.

7. Personal Property

I understand that the Association is not responsible for loss, theft, or damage to any personal belongings brought to the Event.

8. Photography & Media Release

I grant permission to the Palo Del Amo Woods Homeowners Association to use photographs or video taken during the Event for community newsletters, social media, website postings, or other Association-related communications without compensation.

9. Severability

If any portion of this agreement is determined to be invalid or unenforceable, the remaining portions shall remain in full force and effect.

10. Acknowledgment of Understanding
